*Represents district 36/37. More to take care of because of redistricting. He was busy due to voting. He wanted to talk about crime. It is higher and he is focused on crime prevention efforts. He has passed some measure in the house and senate that should lower crime rates. Bill for witness protection program. Funds available for witness protection to help in regards to crime prevention. Bill was passed in house to allow salaries to reset for police which will lead to better pay, recruitment, and retention. Blair's Law was supported by the Governor and hopefully will be passed this year.

- -Mark Sharp chairs a committee to help communities fight crime and taxes for seniors. Voted in favor of property tax freeze.
 - -Questions about property taxes and his stance.
 - -Asked if surveys go out to constituents, when they go out.
- -Top 3 issues he's working on: 1) Taxes: freeze Taxes 2) Crime: Blair's Law, KC reps know constituents want local control of police and 3) Education: open enrollment for schools would/could be bad for poorer communities

Acting Treasurer: Mark Broeker

- *A year-to-date financial report was provided and reviewed. Budget for 2024 is set at \$23,807, a reduction of \$2,018 from 2023. Expenses for 2023 were less than expected due to unused monies for Adm Services. Snow Removal, and Directory Printing. We left \$4000 in reserve for 2023 since we still have the potential for wintry precipitation.
 - *We changed insurance carriers which resulted in an annual savings of approximately \$1600.
 - *We are actively pursuing replacing Wanda via a 3rd party HOA management service and/or local resident should someone be interested.
 - *Currently there are 17 delinquent accounts for unpaid dues with plans to file liens and/or send these accounts to collections. Data suggests a correlation between Code Violations (311) and unpaid dues.

*The Board is reviewing and updating records for our checking and CD accounts with US Bank and First Federal.

Secretary: Joe Jackson

- *Directory will go out after the first of the year. Will send out every 2 years instead of annually.
- *Dues: will stay at \$75. It was noted that we should vote on this in the future.
- *Five openings for a 2 year term Katie is the only existing member up for a vote.
- *Candidates: Katie Mahoney, Peter Noel, and Ryan Born
 - -Ryan was not present at the meeting.
