Watch out for Porch Pirates!

- Package delivery is increasing over the holidays and with it the risk of theft. Here is how you can submit a police report to the Kansas City Missouri south patrol division for package theft.
- Gather information
 - Package details: Name of the retailer, Date of the order/ Date of the expected delivery, Name of the carrier & Tracking number, Description of the package contents & Estimated value of the package.
 - Evidence: Security footage of the theft (if available), Witness statements (if any), Photos of the package (if available), Packaging materials (e.g., receipt, shipping label).
- File the report. There are two ways to file a police report for package theft in Kansas City, Missouri
 - Online: Visit the KCPD Online Reporting website

 - Select "File a Police Report"
 - Choose "Theft" as the type of crime
 - Select "Other" as the sub-type (unless you have specific evidence)
 - Provide the requested information, including your contact details, the date and time of the theft, and the location where the theft occurred
 - Upload any evidence you have
 - Submit the report
